



WHAT IS SENATE BILL 1383?

Senate Bill 1383 (SB1383) is a California state law to decrease greenhouse emissions by reducing the amount of organic waste that ends up in landfills. A key part of SB 1383 aims to reduce unnecessary food waste and food insecurity, by recovering food that would otherwise go to landfill. **By 2025, California businesses will recover approximately 20% of edible food by donating it to food recovery organizations.**

ACCORDING TO THE U.S. DEPARTMENT OF AGRICULTURE, ROUGHLY 30 - 40% OF THE FOOD SUPPLY GOES TO WASTE YEARLY, EQUATING TO 133 BILLION POUNDS OR \$161 BILLION WORTH OF FOOD.

HOW DOES THIS IMPACT YOUR BUSINESS?

Certain food-related businesses called Commercial Edible Food Generators (CEFGs), are required to donate the maximum amount of surplus food to a Food Recovery Organization. CEFGs are classified into two groups:

TIER 1 GENERATORS (JAN. 2022)

- Grocery Stores
- Food Distributors
- Food Service Providers
- Wholesale Food Vendors

TIER 2 GENERATORS (JAN. 2024)

- Restaurants
- Education Agencies
- Hotels
- Large Events
- Health Facilities
- Large Venues
- State Agency Cafeterias

By January 2024, all CEFGs must meet the following requirements:

- **Maintain a contract or written agreement with a Food Recovery Organization.**
- **Maintain records of donations indicating all types of food being donated in pounds per month, frequency of donations, and contact information of contracted Food Recovery Organizations utilized.**
