1. CALL TO ORDER

The teleconference call meeting of the WRCOG Special Central Zone TAC was called to order at 8:05 a.m. at the County of Riverside Administrative Center, 3rd Floor in Christopher Gray's office.

3. REPORTS/DISCUSSION

A. Funding for Heacock Road (City of Moreno Valley)

Christopher Gray stated the City of Moreno Valley requested to make an amendment to the 2016 Central Zone 5-Year Transportation Improvement Program (TIP) by adding a new project; Heacock Street between Gentian Avenue and Iris Avenue.

Committee member Ansari reiterated that the City's request is regarding Heacock Street. This particular street is between Iris Avenue to Gentian Avenue and is approximately 2,600 linear feet, which has remained a bottleneck two-lane road and is a TUMF eligible facility. Due to timing and the construction on the Heacock Channel, the City of Moreno Valley is requesting to add \$800,000 for the construction phase in Fiscal Year 2015/2016.

Michael Lloyd added that the timing aspect regarding the channel is critical. The channel project has been going on for about 12 years. The City has received an \$8 million grant for the construction of the Heacock Channel with the funds available October 1, 2016.

Mr. Gray clarified to the Committee that the City of Moreno Valley is at the risk of losing \$8M in federal funding if the City does not proceed with widening the road and asked if the City put out a request for proposal or bids for construction of the channel project?

Mr. Lloyd replied that the City has not yet advertised for bid because an agreement is not in place between Riverside County Flood Control and March Air Reserve Base.

Mr. Gray indicated that there is currently unallocated funds within the Zone for Fiscal Year 2015/2016. There is funding available which will not require a reallocation of funds from existing projects. The TIP can accommodate this request, there is funding for this request and it does not appear to significantly affect other projects that are underway.

Habib Motlagh indicated that the City of Perris is aware of the project and has been involved in the channel project. The City of Perris supports the project because it helps with the circulation of the transportation system.

Dan Fairbanks added that the Riverside County Flood Control project is moving forward. It does add positive things in terms of taking 300 homes out of the flood plain and taking a portion of March Reserve Base out of the flood plain. The street improvements are critical as part of that whole project.

Patricia Romo indicated that the County of Riverside understands the need for the project and potential loss of federal funding for the channel project and the County of Riverside is in support of the City. The County's concern is making sure that any projects that are under construction remain unaffected. Mrs. Romo asked if the City of Moreno Valley has secured other funding for the Heacock Street widening

Mr. Lloyd replied that the City has a \$400,000 Measure A match.

Jonathan Smith agrees and appreciates the approach to the projects and the agencies putting projects forward. Scott Road and Holland Road overcrossing projects will soon be under construction. The City is in support of the project.

M/S/A 5-0-0; Item 3.A was approved by a unanimous vote of those members present.

Mr. Gray indicated that Donna Dean will make the appropriate adjustment to add the project and updating the TIP for this fiscal year.

B. Funding for Nuevo Road/I-215 Interchange (City of Perris)

Christopher Gray stated the City of Perris requested to make an amendment to the 2016 Central Zone 5-Year TIP as well.

Habib Motlagh provided background of the City's request. The City of Perris has a project titled Evans Road that is currently on the TIP. There is one phase that Mr. Motlagh is working with developers to build the facilities and will not request TUMF reimbursement. The request is to remove the balance that is available currently on the TIP for the Evans Road project and transfer to a new project, Nuevo Road/I-215 Interchange. The City has partial funding from Riverside County Transportation Commission from Measure A of \$1.6M and will be going out to bid on February 19, 2016. The City is requesting that the remaining balance of Evans Road be moved to Nuevo Road Interchange, Phase 1 Construction. Most of the funding will be used in Fiscal Year 2016/2017. Construction will begin in April 2016 and will be about 10 months.

Ms. Dean mentioned that interchanges are not done in phases.

Mr. Gray asked Committee Member Motlagh to explain what the improvements are for the project.

Committee Member Motlagh replied that the improvements are widening two ramps (northbound and southbound), adding retaining walls, and signals. The City is not adding any additional funding to the TIP. The City is asking to remove the funding of the two phases for Evans Road.

Mr. Gray restated for the Committee that the City currently has about \$1.3M programmed on Evans Road. WRCOG would move that funding for Nuevo Road/I-215 and there is no net change on the TIP.

Historically WRCOG has not done phases to interchange by policy but there have been a couple of instances where it has been done with delay between phases. A discussion needs to occur on how project phases are reflected in the Nexus Study and future documentation.

Jonathan Smith added that the interchange projects are increasing in cost and agencies are struggling to keep up. The City is looking at ways of phasing in these improvements. This is an issue that will continually be brought up.

Mr. Gray mentioned that WRCOG could address this through the Nexus Study by deducting previously reimbursed funding from the overall identified costs in the TUMF Network.

Committee Member Motlagh agreed that previously reimbursed funding need to be deducted from the overall allocated cost in the TUMF Network.

Patricia Romo indicated that the County does not have any concerns with this request. They are in support of it and its not changing the bottom line of the TIP and can prove to be cost effective by accelerating a phase now while construction prices are low.

Ahmad Ansari mentioned he use to work hand-and-hand with Mr. Motlagh on this project. There are important elements to the project; as there is no net change to the project, the City of Moreno Valley will be in support of this request.

Committee Member Motlagh requested to clarify that the City of Perris has a current project Evans Road that is two phases. The City wants to eliminate one of the phases and move the funds to Nuevo Road/I-215 Interchange.

Mr. Gray asked if funding from Evans Road is moved to Nuevo Road and Evans Road is left on the TIP, what balance amount would be left on Evans Road.

Committee Member Motlagh replied that he didn't know if so, it will be a minimal amount for engineering work.

Mr. Gray reported that WRCOG is in support of reallocating funds from Evans Road for this new project assuming that there is no net change in the TIP.

M/S/A 5-0-0; Item 3.B was approved by a unanimous vote of those members present.

WRCOG will need additional information from these two projects. Adjustments to the TIP will be made and sent out to the Central Zone TAC Committee for final consensus after all the documentation is received. This will be the last TIP amendment until fall 2016.

4. ITEMS FOR FUTURE AGENDAS

There were no items for future agendas.
