7. REPORTS / DISCUSSION

A. SB 1383: Short-lived Climate Pollutants Workshop Update

Casey Dailey opened the discussion regarding WRCOG's role in assisting member jurisdictions with implementation and compliance efforts for SB 1383.

Kyle Rodriguez presented the operational timeline within which Cities must bring codes, hauler agreements, and staff enforcement up to standards to meet the 75% organics disposal reduction goal by the year 2025. Jurisdictions are required to expand or create an organics collection program, inclusive of all hauler agreement negotiations, collection rates, and infrastructure capacity, by January 1, 2022. WRCOG surveyed the Solid Waste Committee for interest in the development of a regional Solid Waste Committee (SWC) SB 1383 Compliance Program.

Olivia Sanchez stated that the City of Riverside has already made its request for proposals and received a bid from Reduce Reuse Recycle (R3) Consulting. Riverside's goal is to have R3 assess its entire Solid Waste Diversion, with a focus on Mandatory Commercial Recycling and Mandatory Organic Recycling. After the SB 1383 workshop held in February 2019, WRCOG staff met with workshop participants, HF&H Consultants, and identified potential economies of scale by developing a region toolkit that interested members could use to comply with SB 1383, in lieu of each member independently seeking consultant support to do the same thing. The estimated cost per jurisdictions, as part of a regional program, is roughly \$10,000, compared to \$20,000 if a jurisdiction seeks to find a consultant independently. This cost estimate would be finalized if WRCOG received authorization to release an RFP for services.

Jill Larner indicated that the cost for a noncompliant City is \$10,000, as it was before with AB 939. Samantha Rodriguez requested a breakdown of direct and indirect costs and recommendations from CalRecycle.

Holly Stuart suggested a discussion with the Coachella Valley Association of Governments.

Charles Russel requested research into the possibility of selecting only necessary pieces of the toolkit, with a mention for SB 1383 inspection support.

Araceli Ruiz suggested that a survey for all members should be sent out with what a consulting tool kit would provide and members can choose what they need and want.

Action: 1. Directed staff to launch a survey to compile assessments on SB 1383.

(Hemet / Banning) 7 yes; 0 no; 0 abstention. Item 7.A was approved. The Cities of Calimesa, Canyon Lake, Corona, Jurupa Valley, Moreno Valley, Murrieta, Perris, San Jacinto, and Temecula were not present.

B. Electronic Annual Reports Update

Kyle Rodriguez reported that the purpose of the Electronic Annual Reports (EARs) is to provide CalRecycle with updates regarding jurisdiction progress in meeting state-mandated waste reduction goals. The 2018 EARs open on June 17, 2019, and are due August 1, 2019.

Staff will be submitting the 2018 EARs on behalf of the Cities of Banning, Calimesa, Canyon Lake, Corona, Lake Elsinore, Murrieta, Perris, San Jacinto, Temecula, and Wildomar. Any additional requests from CalRecycle will be executed by WRCOG. This upcoming report has been requested to include accuracy of reported compliant and non-compliant waste generators for both commercial and multi-family generators.

C. ReCollect: Online Waste Services Update

Kyle Rodriguez shared an update on WRCOG's waste and recycling communication platform, ReCollect, an educational toolbar that provides residents, businesses, and waste haulers proper waste disposal information, available as an embedded webpage widget and a mobile application.

ReCollect gathers non-confidential residential data in order to provide users with an accurate collection calendar and location-based event notifications. This online tool is available for all SWC members. CR&R contracted cities are ready to go live with this online tool. Waste Management (WM) contracted cities will be available once it requests and obtains the residential data.

Staff will provide embedding assistance to member jurisdictions, as needed. The City of Hemet has placed a widget on its website, and the City of Wildomar has began testing embedding, waiting on the remaining address data to be uploaded by WM.

D. Household Hazardous Waste Grant Application

Rayza Sison reported that WRCOG has applied for CalRecycle's 33rd cycle of the Household Hazardous Waste (HHW) Small Projects Grant. The purpose of the grant is to provide funding opportunities to local governments to implement or expand programs that promote the collection, source reduction, reuse, and recycling of HHW. \$1,000,000 is available within the grant cycle for Fiscal Year 2019/2020.

WRCOG, as a Joint Power Authority, is eligible for a maximum of \$100,000. WRCOG utilized Blaise & Associates' grant consulting and writing services to apply for the grant. The proposed funding will be used to expand existing solid waste infrastructure, fund information tools, and expand youth programs to be inclusive of HHW. Awards will be announced July 17, 2019, with funding priority given to applicants who have not received HHW grant funding within the past three years.

Kyle Rodriguez introduced mattress recycling as a possible item for discussion.

Olivia Sanchez and Jill Larner offered to present information on CalRecycle's mattress recycling efforts, which include abatement programs. Both suggested inviting Mark Patti, Southern California Representative for the Mattress Recycling Council, to speak on California's ByeBye Mattress Program.

Kyle Rodriguez surveyed interest regarding tire recycling; the Cities of Menifee, Riverside, and Wildomar all expressed the need within their jurisdictions. CalRecycle provides tire-specific grants that may be used to fund cleanups, abatement, and proper disposal or recycling.

The purpose of this item is to provide an update on the Used Oil and Filter Exchange Program's events, community outreach activities, and the social media campaign.

Requested Action:

WRCOG's Environmental Department assists member jurisdictions in meeting state mandates which require education and outreach programs that reduce greenhouse gas emissions and preserve land and habitat conservation. WRCOG's subregional Used Oil Recycling Program is designed to promote the proper recycling and disposal of used oil, oil filters, and Household Hazardous Waste (HHW).

Used Oil and Filter Exchange Events

The Used Oil Program is funded by a grant from CalRecycle, which allows jurisdictions to provide outreach and education on the proper recycling of used motor oil, oil filters, and HHW. WRCOG provides outreach on behalf of the 16 member jurisdictions that participate in the Used Oil Program. The primary objective is to teach "Do It Yourself" (DIY) individuals who change their oil how to dispose of their used oil and oil filters properly; therefore, an auto parts store is an excellent venue for events. During used oil events, individuals are encouraged to bring in their used oil filters for recycling. In exchange, they are provided with a new filter, of equal or lesser price, at no cost. WRCOG staff utilizes an electronic survey on an iPad to interact with residents at these events and collect information to help better inform community members of future opportunities to recycle used oil. In addition to promoting used oil and oil filter recycling, staff provides information about future County-wide HHW Collection Events, which allows residents to drop-off other automotive and hazardous household products for free.

Social Media Campaign Update

The Used Oil and Filter Exchange Program relies on marketing and promotion efforts to attract residents to various events throughout the region. While radio advertising reaches a vast amount of members of the community it doesn't allow for a targeted audience in any geographical area. In Fiscal Year 2017/2018, WRCOG staff intitated a pilot digital outreach campaign for the Used Oil Recycling Program. WRCOG brought on consultant support to develop a Facebook advertising campaign that focuses on increasing RSVPs to upcoming outreach events. Facebook also allows for straightforward tracking, hands-on optimization, and highly specialized targeting. By targeting special groups of people, an effective marketing communication is developed and communication is specific to individuals who are the most likely to attend an event and exchange their used oil filter.

Staff has concluded the pilot digital advertising campaign for the Program was a success. WRCOG's oil filter collection numbers increased over 27% from last year to this year. Additionally, over 1 million impressions were made online, with many positive reactions and shared posts. While the number of events have stayed consistent, the focus on an online platform promotion has driven the number of attendees up. Last year the number of community members reached was 906, this year it was over 5,800, a 540% increase. Based on the success of the pilot campaign, WRCOG staff intends to continue using social media as the primary advertisting platform for its Used Oil and Filter Exchange Program.

Lessons learned from this campaign are being applied to future outreach initiatives, both online and offline, such as engagement regarding hazardous waste disposal, common knowledge of oil recycling, and a call to action to suggest members share information with friends and family. All three audience groups (DIY, green living, and car / motorcycle enthusiasts) work well for an event response campaign with relevant messaging. Ads generated an exceptional number of shares, driving incremental reach beyond the paid efforts of the campaigns. Most of the users reached had an overwhelmingly positive response to the ad creatives and were

excited to have used oil events in their community.

The purpose of this item is to provide information about current and upcoming CalRecycle grant opportunities pertaining to recycling efforts and program implementation that may affect member cities.

Requested Action:

1. Receive and file.

WRCOG tracks grant opportunities relevant to the Solid Waste Committee with regards to supporting the increase of markets for recyclable or compostable materials, funding for programs to reduce litter and illegal dumping, and removing the cost burden for disposal of recyclable products from local jurisdictions and agencies. All grants listed below are released and administered by the Department of Resources Recycling and Recovery (CalRecycle). Further information can be found at www.calrecycle.ca.gov/funding.

Beverage Container Recycling Grant Program

CalRecycle administers this grant to provide opportunities for California local government agencies, cities, counties, regional programs, public colleges and universities, public school districts, non-profit organizations, and qualifying Indian Tribes to promote increased recycling of beverage containers throughout California and reduce the beverage container litter in the waste stream. Eligible projects include the expansion of an ongoing recyclables collection program or a pilot collection program.

Status: Application materials for Fiscal Year (FY) 2020/2021 will tentatively be available spring 2020.

Impact: Minimum funding of \$75,000, maximum funding of \$500,000.

Eligible applicants include California cities and counties; Joint Powers Authorities; Special Districts (e.g., recreational park districts); public colleges, universities, and public K-12 school districts; non-profit organizations; and qualifying Indian Tribes.

Illegal Disposal Site Abatement Grant Program

CalRecycle administers this grant to provide opportunities to clean up solid waste sites and solid waste at codisposal sites where the responsible party either cannot be identified or is unwilling or unable to pay for timely remediation and where cleanup is needed to protect public health and safety and/or the environment. Eligible projects include waste removal and disposal or the construction of security measures (fences, barriers, signage, etc.) to prevent recurring illegal dumping at remediated sites.

Status: Application materials for FY 2019/2020 or 2020/2021 is expected to be available fall 2019.

Impact: Maximum funding of \$500,000.

Eligible applicants include California cities and counties; Joint Powers Authorities; Special Districts (e.g., recreational park districts); and State Agencies.

Food Waste Prevention and Rescue Grant Program

CalRecycle administers the Food Waste Prevention and Rescue Grant Program to provide opportunities to lower overall greenhouse gas emissions by establishing new or expanding existing food waste prevention projects (source reduction or food rescue for people) in California, thereby reducing the amount of food being disposed of in landfills. Eligible projects include food waste prevention that covers education, outreach, modernization of production or handling, and food preparation waste reduction, as well as food rescue projects that result in edible food rescue and distribution or otherwise composting, digesting, or diversion.

Status: Application materials for FY 2020/2021 is expected to be available winter 2020.

Impact: Minimum funding of \$50,000, maximum funding of \$500,000.

Eligible applicants include local governments (cities, counties, regional or local sanitation agencies, waste agencies, or Joint Powers Authorities); non-profit organizations; private, for-profit entities; state or federal agencies (including offices, department, bureaus, and boards); University of California campuses, California State University campuses, or the California Community College campuses; solid waste facilities; public School Districts; and qualifying Indian Tribes.

Local Government Waste Tire Cleanup Grant Program

CalRecycle administers the Local Government Waste Tire Cleanup Grant to provide funding opportunities for the collection, removal, transportation, recycling, and disposal of waste tires from illegal tire piles and areas where illegal dumping has occurred along public rights-of-way. Eligible projects include tire remediation up to \$8.00 per tire and cleanups that include salaries and benefits for personnel directly involved in waste-tire cleanup projects, equipment rental, and reasonable costs of fencing, gates, signage, and other security measures.

Status: Application materials for FY 2020/21 will tentatively be available winter 2019.

Impact: Maximum funding of \$100,000 for a single jurisdiction and \$250,000 for a regional applicant.

Eligible applicants include California cities and counties; Joint Powers Authorities; Special Districts (e.g., recreational park districts); and qualifying Indian Tribes.

Local Government Waste Tire Amnesty Grant Program

CalRecycle administers the Local Government Waste Tire Amnesty Grant to provide funding opportunities for date-specific events for the public and are not intended for the disposal of waste tires from waste tire generating businesses. Amnesty events either 1) allow citizens to bring waste tires to convenient locations for proper management up to twice per month per location, or 2) can consist of a coupon program that allows citizens to bring in waste tires on specified days.

Status: Application materials for FY 2021/2022 is expected to be available winter 2020.

Impact: Maximum funding of \$40,000 for a single jurisdiction and \$90,000 for a regional applicant.

Eligible applicants include California cities and counties; Joint Powers Authorities; Special Districts (e.g., recreational park districts); and qualifying Indian Tribes. Grants will not be awarded to two agencies within the same jurisdiction (e.g., two departments of the same city).

California Used Mattress Recovery and Recycling Act

CalRecycle provides oversight for the statewide mattress recycling program, stewarded and implemented by the Mattress Recycling Council (MRC). Residents who wish to recycle their old mattress and box spring may visit the following recyclers, renovators, or drop-off locations in Western Riverside County:

This fee applies to every mattress and box spring sold as of December 30, 2015. Residents can drop off their old mattress at no-cost at a participating collection site or recycling facility. The \$3 reimbursement per mattress is only given at participating recycling facilities. It is limited to five units per person, per day.

The purpose of this item is to provide an open table discussion of Senate Bill 1383 Short-lived climate pollutants and to determine if there is a role that WRCOG can fill.

Requested Action:

1. Discuss and provide direction, if necessary.

Background

In October 2018, staff held one-on-one meetings with members of the Solid Waste Committee (SWC) and was asked to focus on recently chaptered legislation, SB 1383. This legislation established targets to achieve a 50% reduction of organic waste from the 2014 statewide level of disposal by the year 2020 and a 75% reduction by the year 2025. The law places CalRecycle as the agency authorized to establish and enforce targets required to achieve the waste disposal reduction goals.

In January 2019, CalRecycle began the formal rulemaking process for the Proposed Organic Waste Reduction Regulations to implement the organic waste landfill reduction requirements of SB 1383.

On February 20, 2019, WRCOG hosted a workshop on SB 1383. Attendees included local representatives from the Cities of Banning, Calimesa, Corona, Desert Hot Springs, Eastvale, Hemet, Indio, Jurupa Valley, Lake Elsinore, Menifee, Moreno Valley, Murrieta, Palm Springs, Riverside, San Jacinto, and Temecula, the Morongo Band of Mission Indians, the Riverside County Department of Environmental Health, and the Riverside County Department of Waste Resources. The workshop was also hosted as a live webinar for interested individuals unable to attend in-person, in which 14 people participated.

Marshalle Graham, a Senior Environmental Scientist for CalRecycle, discussed the organic waste reduction requirements jurisdictions must abide by, along with the deadlines that jurisdictions are required to meet, as necessitated by AB 32 and specified by SB 1383. Residential and commercial organic waste generators are both subject to regulation through organic food waste collection systems. Solid waste haulers and facilities that service both parties are subject to additional recovery requirements. Other requirements that fall upon involved parties include the expansion or creation of edible food recovery programs, educational outreach opportunities for generators and haulers, and use of recycled content products, composting, and renewable natural gas, when applicable and affordable.

Philip Mainolfi of HF&H Consultants discussed the impacts of SB 1383 draft regulations upon member jurisdictions. Jurisdictions must expand or create an organics collection program, within which hauler agreement negotiations, collection rates, and infrastructure capacity must be implemented by July 2021. Required ordinances and policies that jurisdictions must create, amend, or implement by the CalRecycle report deadline include those involving recycling / organics for all generators, self-haul reporting, edible food recovery, CALGreen building standards, enforcement, hauler regulation, and procurement policies.

Current Issue

WRCOG is currently researching and exploring options on providing support to member jurisdictions in developing and implementing a Compliance Program. WRCOG was approached by HF&H Consultants regarding involvement in SB 1383. Members of the SWC will discuss what WRCOG's role should be regarding SB 1383 compliance and bringing on consultant support on a regional contract, or individual city contract. If members proceed alone, prices will be higher than working as a collective.

At the May 2019 SWC meeting, WRCOG was asked to survey the members based on the researched requirements of a possible SB 1383 toolkit. The survey was distributed via email using Google documents. A link was sent to all members on June 16, 2019, which contained a seven question survey. The survey and responses are attached to this Staff Report. Based on the survey results, two topics emerged with over 50% of respondents indicating the need for assistance.

- 1. Developing an inspection and enforcement program to review commercial solid waste accounts; and
- 2. Identifing inspectors for eligible food generators and food recovery facilities.

Staff is looking into CalRecycle's food waste grant to help plan and address the committee needs based off the SB 1383 survey. WRCOG is looking to help gather the necessary data of food generators and food recovery facilities within Western Riverside County. For the time being, efforts are being made to learn more about cities' current work with SB 1383 implementations, including any waste hauler amendments and ordinances passed, upcoming workshops pertaining to 1383, and connecting with all interested parties on strategies to enforce SB 1383 compliance.

Prior Action:

May 15, 2019: The Solid Waste Committee directed staff to launch a survey to compile assessments on

SB 1383.













The purpose of this item is to provide an update on CalRecycle's Electronic Annual Reports.

Requested Action:

Receive and file.

The Electronic Annual Report (EAR) describes the progress a jurisdiction has made in achieving the requirements of the Integrated Waste Management Act (AB 939, Chapter 1095, Statutes of 1989) and the Per Capita Disposal Measurement Act of 2008 (Chapter 343, Statutes of 2008 [Wiggins, SB 1016]). The EAR also includes status on any planned and/or implemented solid waste diversion programs and facilities. These reports were submitted on August 1, 2019.

EAR Update

On an annual basis, WRCOG staff prepares the EAR on behalf of those jurisdictions which request WRCOG to complete. Based on feedback from previous years, staff began the reporting in early January utilizing Google Documents. The online tool allowed WRCOG, local jurisdictions, and waste haulers to draft a report well in advance of the submission due date. WRCOG reached out to members of the Solid Waste Committee for feedback on prior years' EARs and was asked to have more involvement with the respective waste haulers. In 2019, WRCOG conducted one-on-one meetings with each waste hauler to gather as much necessary data for the report that was requested to be provided. Disposal and recycling tonnages, educational and outreach events, and any program changes initiated were confirmed by both the jurisdiction and the waste hauler.

Staff communicated consistently with CalRecycle on the continued diversion requirements, particularly regarding AB 341 (Mandatory Commercial Recycling) and AB 1826 (Mandatory Organics Recycling). The EAR required jurisdictions to report on compliance for the diversion regulations, including how many businesses and multi-family residences were required to comply, how many are in compliance, and how they were informed of the recycling requirements. CalRecycle hosted meetings (teleconference and/or onsite) with jurisdictions and WRCOG in order to communicate required measurements.

This year, WRCOG submitted the EARs on behalf of the Cities of Banning, Calimesa, Canyon Lake, Corona, Lake Elsinore, Hemet, Murrieta, Perris, San Jacinto, Temecula, and Wildomar on, or before, August 1, 2019. If additional information is required by CalRecycle, WRCOG will follow-up accordingly and notify jurisdictions of any updates.

The purpose of this item is to provide an update on WRCOG's application for the California Department of Resource Recycling and Recovery's (CalRecycle) 33rd cycle of the Household Hazardous Waste Grant for small projects being approved.

Requested Action:

Background:

The California Department of Resource Recycling and Recovery (CalRecycle) administers the Household Hazardous Waste (HHW) Grant Program to provide funding opportunities for local governments to implement programs that promote the collection, source reduction, reuse, and recycling of HHW. There were 16 small projects where were awarded grant funds that included one or more of the following: HHW public education and outreach for residents; implementation of sustainable HHW collection opportunities; projects to determine safe and cost-effective methods for collection of HHW; set-up and operation of temporary or mobile collection programs; new or expanded curbside collection program; and/or improvements to an existing HHW facility.

Grant Update

In January, 2019, WRCOG applied for funds to expand public outreach and recycling education in the subregion on items such as antifreeze, batteries, oil, and paint, which require special care for disposal.

In July 2019, WRCOG was notified that it has been awarded \$60,000 to administer its project, which expands upon its existing waste, recycling, and reuse programs. The grant funding will assist WRCOG to reach and impact in the subregion, providing additional resources for incorporated cities, unincorporated county areas, and water districts in Western Riverside County.

WRCOG's proposed project includes:

- Purchasing additional hazardous waste collection tanks and drums for antifreeze, batteries, oil, and paint to be placed at 33 of 165 Certified Collection Centers (CCCs)
- Expansion of outreach and educational efforts through 25 HHW disposal and recycling events across
 Western Riverside County
- 1 3 youth-focused educational events with environmentally-friendly curriculum to cover topics of habitat conservation, correct disposal methods, and recycling habits

Prior Action:

April 1, 2019:

The Executive Committee adopted WRCOG Resolution Number 06-19; A Resolution of the Executive Committee of the Western Riverside Council of Governments authorizing submittal of application(s) for all CalRecycle grants for which the Western Riverside Council of Governments is eligible.

AB 341 and AB 1826 Compliance Monitoring Web Portal and Tracking Service

Introduction:

MSW Compliance is a web portal and tracking service that enables California cities to effectively and
efficiently manage, monitor, and report on the recycling outreach activities directed toward
commercial waste generators.

Background:

- The State of California requires certain covered businesses and multi-family complexes to participate in recycling and organics recycling.
- CalRecycle requires all cities to outreach, educate, and monitor the compliance of each covered business and multi-family complex.
- In the near future, CalRecycle will require cities to assess fines and penalties on non-compliant businesses.

Challenge:

- CalRecycle requires targeted outreach to individual covered businesses, with documentation.
- The "At Any Time Review" process (PRC 42649.3(h)) authorizes CalRecycle to review a city's documentation related to outreach, education, and monitoring activities throughout the year, on short notice.
- Cities typically do not have staff dedicated full-time to AB 341 and AB 1826 compliance.
- Cities rely on franchised haulers to provide crucial information on which they are evaluated.
- Hauler billing systems do not track certain recycling compliance characteristics (i.e. third-party recyclers, exemptions, self-hauling, etc.).
- Hauler billing systems do not show how customer compliance changes over time, which CalRecycle relies on to evaluate the effectiveness of the jurisdiction's outreach and education activities.





- Allows collaboration among multiple users including cities, haulers, and outreach contractors.
- Promotes ongoing communication between cities and their waste haulers.
- Enables cities to maintain control of information for which they are responsible to CalRecycle.
- Enables cities to promote and document sustainable practices among their commercial businesses.
- Enables users to document exemptions and violations (i.e., photos, notes, correspondence, etc.).
