5. REPORTS/DISCUSSIONS

A. California Department of Resources Recycling and Recovery (CalRecycle) Update

Francis Bean mentioned a monthly meeting for CalRecycle urging participation from staff and indicates dates are monthly and online. In discussing grant money, Mr. Bean reported there should be representatives that receive notifications of grants. Mr. Bean indicated that Greenhouse Gas Reduction is the next big available grant. A map was discussed that shows communities where environmental help is needed; especially for low income areas. Dolores Badillo mentioned the City of San Jacinto (Mike Emberton) requested assistance with a tire grant they were interested in applying for. Unfortunately, they found out that ultimately, they could not afford materials that were not covered by the grant. The question came out to: How could labor be included in grant? Mr. Bean mentioned that cities need to be aware of fine print and rules of grant and suggested applicants should look for examples of other communities. He said there are very specific rules, and CalRecycle can assist, up until the time the grant is open. Mr. Bean brought up the Electronic Annual Reports and said AB341 and AB 1826 would be a focus for the reporting year. The goal is by 2020 that a major mandate could be triggered.

B. Waste Hauler Update

Nicole Moore, CR&R, provided an update on the Anaerobic Digester that is located at CR&R's facility in Perris. Ms. Moore said that CR&R has started up 3 of the 4 digesters and are currently feeding product to all 3 digesters in Phase 1. Over the next 3 months they will be bringing the digesters up to full capacity approximately 50 tons each. The machine is working, has not filled to full capacity yet. It will take approximately eight to ten weeks to be filled. The process is taking more time than expected but the task will be completed nevertheless. CR&R will have a Ribbon Cutting event soon.

Carolyn Anderson, Waste Management, reported that on November 19, 2017, the Community of Nuevo will host an event at Nuevo Elementary School. In will include document shredding, ewaste, and tires will be collected. Educational information for the public will be passed out. The Mead Valley clean up event is scheduled for November 12, 2017.

C. Lake Elsinore Pilot Litter Initiative

Kyle Rodriguez, WRCOG Intern, presented the Lake Elsinore Pilot Litter Program and focused on the Program's five key components. He spoke about community education with schools and businesses. He added that school visits will be made to elementary, middle school, and high schools within the city. He talked about the collaboration with outside agencies as well as making connections with businesses on Main Street. CR&R is in full support with the Lake Elsinore Pilot Program and WRCOG would like to also partner with Waste Management in the future. Mr. Rodriguez gave an update on the Adopt-A-Highway Program and how it will be utilized as a marketing tool. Also discussed was the use of signs, banners, flyers, stickers for the Program that will be available to the public. He talked about the "No Litter Pledge" that has been handed out for community members to sign. He also reported that program support has increased with the involvement of Riverside County Flood Control, Barron's Furniture and Appliances and Lowes.

D. Riverside County Backyard Composting Program

Janet Moreland Recycling Specialist with the Riverside County Department of Waste Resources presented on the history and future of residential composting and training provided by the County. The Program started in 1993 and is still growing. The goal is to make it inexpensive and safe for all residents. They currently schedule four workshops per jurisdiction; some jurisdictions do not have workshops but are near neighboring jurisdictions. Ms. Moreland asked if members could help promote workshops to help gain support. The Department is currently selling "geo bins" for composting. The Volunteer Program has master composters to help attendees of the workshops understand composting. A new schedule will be handed out for the year. Events in jurisdiction will have suppliers for residents. These classes are offered in the morning. Ms. Moore outlined a new program that helps attendees learn about and create their own simple cleaning materials at home that allow for fewer chemicals. Many people are unaware of what to recycle in a compost bin; these workshops are very beneficial to the public.

The purpose of this item is to provide the Committee with an update on the Regional Used Oil and community outreach events.

Requested Action:

WRCOG's Solid Waste Program assists member jurisdictions with addressing state mandates, specifically from Assembly Bill AB 939 (Chaptered in 1989), which required 25% and 50% diversion of waste from landfills by 1995 and 2000, respectively. While certain aspects of AB 939 have been modified over the years with legislation defining what materials counted towards diversion and how to calculate the diversion rate for jurisdictions, the intent of the bill remains. The Solid Waste Program also has a Regional Used Oil component which is designed to assist member jurisdictions in educating and promoting proper recycling and disposal of used oil, oil filters, and household hazardous waste (HHW) to the community.

Recycling Program Activities Update

<u>Used oil events</u>: WRCOG's Used Oil and Oil Filter Exchange events help educate and facilitate the proper recycling of used motor oil and used oil filters in various WRCOG jurisdictions. The primary objective of hosting the events is to educate "Do It Yourself" (DIY) individuals who change their own oil, the DIYer, promoting the recycling of used oil and oil filters; therefore, an auto parts store is a great venue for educating the DIYer. In addition to promoting used oil / oil filter recycling, WRCOG staff informs the DIYer about the County-wide HHW Collection Program where residents can drop-off other automotive and household hazardous products for free.

WRCOG staff hosted twelve Used Oil events and participated in three community events over the past several months in the subregion.


