The purpose of this item is to request approval of a resolution which will authorize certain officers to sign and enter into contracts in the name and on behalf of the Foundation.

Requested Action:

1. Adopt Resolution Number 01-18; A Resolution of the WRCOG Supporting Foundation, a California Nonprofit Public Benefit Corporation ("Foundation"), to Authorize Certain Officers to Sign and Enter into Contracts in the Name and on Behalf of the Foundation.

WRCOG has established policies that address the authority in executing agreements, both monetary and non-monetary; however, neither of the policies formally address the WRCOG Supporting Foundation specifically.

In some cases, staff will apply for grants or funding mechanisms to support Agency activities. The process can be competitive and require a timely response that may not be possible with the regular meeting schedule of the Supporting Foundation. In order to address the potential limitation to applying for and receiving funding, staff is requesting that the Board of Directors adopt Resolution Number 01-18, authorizing in the best interest of the Foundation to require two signatures to contracts entered into by the officers of the Foundation.

The Resolution also authorizes that in certain circumstances it may be necessary to authorize a different officer to sign a contract allowing for flexibility to act in that event. WRCOG's Supporting Foundation Chairman / President and Executive Director / Secretary will be authorized to sign applications, contracts, and other funding mechanism documents on behalf of the Supporting Foundation unless in circumstances when either is not available and a different officer will sign on behalf of the Foundation.

Staff would bring the information of potential award to the Supporting Foundation for review and approval at its regularly scheduled meeting, or at a special meeting, if mandated time frames require it, in order to accept the funds in the time allowed by the grantor.

RESOLUTION NUMBER 01-18

A RESOLUTION OF THE WRCOG SUPPORTING FOUNDATION, A CALIFORNIA NONPROFIT PUBLIC BENEFIT CORPORATION ("FOUNDATION"), TO AUTHORIZE CERTAIN OFFICERS TO SIGN AND ENTER INTO CONTRACTS IN THE NAME AND ON BEHALF OF THE FOUNDATION

WHEREAS, difficulties arose during a recent project involving the question of the authority of the President of the Foundation to enter into and sign contracts to bind the Foundation; and

WHEREAS, the Board of Directors of the Foundation wishes to remove any uncertainty in the future of the authority granted to the President of the Foundation to enter into and execute contracts in the Foundation's name and on its behalf: and

WHEREAS, the Board of Directors has been advised by legal counsel that best practice to ensure that no single representative has the ability to bind the Foundation without the knowledge of the Board or other officers is to require a second signature on future contracts; and

WHEREAS, the Board of Directors is aware that certain circumstances may arise whereby it is necessary or deemed advisable to authorize a different officer to sign a contract and wishes to maintain flexibility to act in that event.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Directors deems it to be in the best interests of the Foundation to require two signatures to contracts entered into by the officers of Foundation.

BE IT FURTHER RESOLVED, that the Board of Directors hereby authorizes the President and Secretary, together, to enter into and execute contracts in the name and on behalf of the Foundation.

BE IT FURTHER RESOLVED, that in the event an occasion arises where it is deemed necessary or advisable to authorize a different officer to execute a contract, the authority may be granted by resolution of the Board of Directors to that specific time and event.

BE IT FURTHER RESOLVED, that in order to provide evidence of the authority being granted to the officers of the Foundation, the Board of Directors expressly instruct its officers to supply a copy of the resolutions set forth herein as conclusive proof of the authority vested by this Foundation and its Directors and officers, to any and all persons or entities entitled to or requiring such proof of authority.
