#### **5. REPORTS / DISCUSSION**

# A. Update on Potential Formation of a Western Riverside County Economic Development Corporation

Elisa Laurel, WRCOG Program Manager, provided an update on the discovery and due diligence that staff have been working on to date, which included outreach to numerous stakeholders and Economic Development Corporations (EDC) across the nation. The next steps in a potential formation is to create a Steering Committee of approximately 20 members, with half drawn from WRCOG's member jurisdictions. The remaining seats would be members representing the private industry, educational, and non-profit institutions.

Staff anticipates that the EDC Steering Committee would hold three monthly meetings to commence in December 2020, with the topics of each of the respective meetings to be announced along with a third-party facilitator. The intended goal of the Steering Committee with staff support is to determine the strategic direction, governance, and potential funding mechanisms to best operationalize the appropriate EDC model for the Western Riverside County subregion. Some major themes included are the needs of a subregional single point of initial contact for employers who are interested in the area, subregional branding, and that the WRCOG subregion's size is preferred for an EDC. Staff shared best practices learned from other EDCs across California. Successful EDCs were often launched by public agencies and then later pivoted to a privately-led model. Public agencies provided seed funding, but the EDC had to eventually stand on its own financially. Privately-led entities are not subject to changes in municipal budgets, elected officials, or changes in administration.

The Steering Committee can work out the details and further decide and examine the potential formation. Staff is requesting three to six representatives of this Committee and, at the November Executive Committee meeting, staff will provide an update and request the designation of at least three members of that Committee to serve on the EDC Steering Committee.

Action:

#### B. Climate Change and Climate Adaptation Efforts

Chris Gray, WRCOG Director of Transportation & Planning, reported that this subregion is subject to various climate-related events such as wildfire, extreme heat, flooding, and drought. WRCOG has performed several studies that address these topics and provide recommendations on how member jurisdictions can mitigate or even avoid its impacts. In July 2020, staff provided a presentation to this Committee that gave an overview of the studies and how they would align within the subregion.

Since the last report, staff have continued to work on related efforts including an update to the subregional Climate Action Plan and the release of Request for Proposal 20-002, which seeks qualified consultants to assist in the development of an Energy Resiliency Plan. Staff have completed substantial work in this area and continues to pursue grant funding for additional studies.

With the four key initiatives presented related to climate change and climate adaptation, staff highlighted the interconnection between the various efforts and how individual member jurisdictions can use the data and analysis for its benefit.

#### C. Santa Ana Municipal Separate Storm Sewer System (MS4) Permit Compliance Program Update

Darcy Kuenzi, Government Affairs Officer with the Riverside County Flood Control and Water Conversation District, provided a presentation on the status of the National Pollutant Discharge Elimination System (NPDES) Municipal Separate Storm Sewer System (MS4) Programs within the Santa Ana region of Riverside County.

The Santa Ana Regional Water Quality Control Board is proceeding with a tri-county (Orange, Riverside, and San Bernardino) permit, as well as an update on the total maximum daily load of bacteria and the homeless encampments. The annual report is due November 30, 2020.

The ICMA Code of Ethics was updated as a result of a number of reviews and revisions over the last three years. It was distributed in June 2020. See below for the Revised Code. More information / explanation it is provided on the ICMA website.

The mission of ICMA is to create excellence in local governance by developing and fostering professional local government management worldwide. To further this mission, certain principles, as enforced by the Rules of Procedure, shall govern the conduct of every member of ICMA, who shall:

- 1. We believe professional management is essential to efficient and democratic local government by elected officials.
- 2. Affirm the dignity and worth of local government services and maintain a deep sense of social responsibility as a trusted public servant.

- 3. Demonstrate by word and action the highest standards of ethical conduct and integrity in all public, professional, and personal relationships in order that the member may merit the trust and respect of the elected and appointed officials, employees, and the public.
- 4. Serve the best interests of the people.
- 5. Submit policy proposals to elected officials; provide them with facts, and technical and professional advice about policy options; and collaborate with them in setting goals for the community and organization.
- 6. Recognize that elected representatives are accountable to their community for the decisions they make; members are responsible for implementing those decisions.
- 7. Refrain from all political activities which undermine public confidence in professional administrators. Refrain from participation in the election of the members of the employing legislative body.
- 8. Make it a duty continually to improve the member's professional ability and to develop the competence of associates in the use of management techniques.
- 9. Keep the community informed on local government affairs; encourage communication between the citizens and all local government officers; emphasize friendly and courteous service to the public; and seek to improve the quality and image of public service.
- 10. Resist any encroachment on professional responsibilities, believing the member should be free to carry out official policies without interference, and handle each problem without discrimination on the basis of principle and justice.
- 11. Handle all matters of personnel on the basis of merit so that fairness and impartiality govern a member's decisions pertaining to appointments, pay adjustments, promotions, and discipline.
- 12. Public office is a public trust. A member shall not leverage his or her position for personal gain or benefit.

#### Western Riverside Council of Governments Executive Committee Meeting Recap October 5, 2020

#### **TUMF Reimbursement Agreements and Amendments**

- The Executive Committee approved the following agreements:
  - 1. **Reimbursement Agreement**: City of Temecula for the Right-of-Way Phase of the French Valley Parkway (Jefferson Avenue to Ynez Road) Project in an amount not to exceed \$1,500,000.
  - 2. **Reimbursement Agreement**: City of San Jacinto for the Project Advancement & Environmental Document, Project Specifications & Engineering, Right-of-Way, and Construction Phases of the State Street Widening Project from Gilman Springs Road to Quandt Ranch Road in an amount not to exceed \$1,138,000.
  - 3. **Reimbursement Agreement Amendment**: The County of Riverside for the Project Advancement & Environmental Document, and Construction Phases of the Hamner Avenue Bridge over the Santa Ana River Project in an amount not to exceed \$4,750,000.

# PACE Programs Review of Consumer Protections and Deferral of Judicial Foreclosure on Delinquent PACE Properties

- Staff provided an overview PACE program consumer protections and consumer touchpoints that are in
  place through the project selection and financing process. Staff also presented information regarding
  property tax payment delinquencies for properties that have PACE assessments compared to those that
  do not, finding that properties with PACE assessments show a lower percentage of delinquencies than
  the general population.
- The Executive Committee approved the deferral of judicial foreclosure proceedings for those properties that are delinquent in their property tax payments.

#### **TUMF Program Year in Review**

- Staff provided a year-end and cumulative review of the TUMF Program. Projected FY 2019/2020 revenues were estimated at \$49.5 million, with actual FY 2019/2020 revenues coming in at \$49.8 million. The month of June generated the highest revenue collected for FY 2019/2020 at \$5.7 million.
- \$910 million have been collected since the inception of the Program in 2003.
- Individual reports are being prepared for each member jurisdiction and will provide information regarding completed and funded projects.

- Staff from SoCalGas and the Integrated Renewable Energy Systems Network presented on an integrative approach for decarbonization and resilience in the preparation of long-range planning efforts, such as General Plans or Climate Action and Adaptation Plans.

#### **State Housing Legislative Update**

- The State Legislature has concluded the 2020 Session.
- 200 housing related bills were introduced, 18 were signed.
- Key bills included:
  - AB 725 (RHNA Allocations)
  - AB 1561 (18-month extension of housing entitlements)
  - AB 1851 (affordable housing on religious institution property)
  - AB 2345 (revisions to the Density Bonus Law)

#### GIS and Transportation Modeling Service Bureau

- WRCOG staff discussed the new GIS and Transportation Modeling Service and the development of guidelines for its implementation.
- GIS and Transportation Modeling are common requests that some agencies do not have resources/staff to implement. The WRCOG will fill that gap, especially for our smaller agencies that do not have GIS capabilities.
- The PDC approved motion to recommend that the Executive Committee adopt the following guidelines for the provision of GIS / Traffic modeling services by WRCOG:
  - Any request from a member agency for GIS or Traffic Modeling Services which requires less than 4
    hours will be provided for at no charge.
  - Any request from a member agency for GIS or Traffic Modeling Services which requires more than 4 hours will be provided at Agency Cost.
  - Any request from a non-member such as a Consultant will be assessed a service fee which will be determined on an individual basis.

#### **October's Future Forward Broadcast**

#### Southern California Freight Strategy

#### **TIP Revenue Forecast**

• When COVID-19 emerged, it was anticipated that TUMF revenue could be impacted significantly causing a need to reallocate funding from the last Transportation Improvement Program (TIP) updates.

- Before COVID-19, revenues were projected at 49.5 M for Fiscal Year (FY) 2019/2020. FY 19/20 revenues exceeded projections at \$49.8M.
- Staff recommended that because revenue collections for FY 19/20 were within budget, there is no need for an additional TIP Update.
- TIP Updates will occur at their regular scheduled time in the beginning of 2021.

#### Potential Project Additions to the Nexus Study

- Staff presented information regarding potential project additions to the TUMF Nexus Study Roadway Network.
- Jurisdictions will be allowed to add projects to the roadway network if specific criteria are met. Criteria include:
  - 4-lanes or more at build-out
  - Carry 20,000 vehicles per day or more
  - Be referenced in a General Plan or other planning document
- Staff will be reaching out to all member agencies to determine if they have additional projects that they would like to add to the TUMF Nexus Study Roadway Network.

#### GIS and Transportation Modeling Service Bureau

- WRCOG staff discussed the new GIS and Transportation Modeling Service and the development of guidelines for its implementation.
- GIS and Transportation Modeling are common requests that some agencies do not have resources/staff
  to implement. The WRCOG will fill that gap, especially for our smaller agencies that do not have GIS
  capabilities.
- The PDC approved motion to recommend that the Executive Committee adopt the following guidelines for the provision of GIS/Traffic modeling services by WRCOG:
  - Any request from a member agency for GIS or Traffic Modeling Services which requires less than 4
    hours will be provided for at no charge
  - Any request from a member agency for GIS or Traffic Modeling Services which requires more than 4 hours will be provided at Agency Cost
  - Any request from a non-member such as a Consultant will be assessed a service fee which will be determined on an individual basis

#### WRCOG to Accept \$48,600 Grant to Evaluate Transit Gaps for Vulnerable Populations

• WRCOG will use the Clean Mobility Options Voucher Pilot Program to evaluate transit options and gaps to attempt to increase access to safe, reliable, and affordable clean transportation options.

### SCAG Regional Early Action Planning (REAP) Program Projects List Discussed

- REAP Subregional Partnership Program is intended to increase planning to accelerate housing production throughout the SCAG region. About \$1.7 million will be made available to WRCOG for these efforts.
- WRCOG is proposing projects that will assist member jurisdictions with technical data to complete Housing Elements and meet RHNA number requirements.
- WRCOG is also proposing to perform a programmatic Environmental Impact Report for the Subregional Climate Action Plan. A programmatic EIR would allow jurisdictions to streamline greenhouse gas emissions analyses, which will help expedite the approval process for housing developments.
- WRCOG is also proposing to utilize REAP funding to establish a Housing Trust Fund and an Economic Development Corporation for the subregion. Staff believes these two major initiatives will contribute to construction of needed homes in Western Riverside County.

# <u>Discussion on the Formation of a Western Riverside County Economic Development Corporation</u> <u>Continues</u>

- Staff provided an update on discovery and due diligence work completed to date, which has included
  outreach to jurisdictions, economic development staff, chambers of commerce, other regional
  stakeholders as well as a number of Economic Development Corporations (EDC) throughout the
  country.
- Major takeaways from these discussions has been that a subregional EDC is needed to fill a void in the subregion, and that the subregion is the proper geographic scale for this effort.
- Staff also shared insights from leading EDCs regarding what has made them successful. A major takeaway from these meetings is that successful EDCs tend to be initially funded and convened by the public sector, and then pivot to being mostly private-sector driven.
- Staff will be providing a similar update to the Technical Advisory Committee and request that it
  designate three to six members to serve on an EDC Steering Committee to continue this discussion, in
  particular to examine in more detail EDC governance, staffing and funding issues.
- Similarly, in November, staff will provide an update to the Executive Committee and request the designation of at least three members to serve on the EDC Steering Committee.

#### **New Members for WRCOG?**

- Staff provided a presentation to the Committee, which was basically an inquiry regarding whether there
  is interest in expanding WRCOG's membership. This issue has been informally discussed in the past.
  Staff suggested that if there is a desire to expand, the Committee should limit its scope to entities that
  relate to WRCOG's priority areas as identified in the Agency's Economic Development and
  Sustainability Framework. Based on that document, it would appear that expertise from the health and
  higher education sectors would be of primary interest.
- The Committee requested staff to return in January 2021 with additional information.

#### **WRCOG Appointments to Outside Agencies**

 Every two years WRCOG's Executive Committee is responsible for making a number of appointments to outside agencies. Recommendations from this Committee regarding these appointments will be forwarded to the Executive Committee for consideration at the November 2, 2020, meeting.

#### Staff Provides TUMF Program Year in Review

- Since inception in 2003, approximately \$900 million has been collected from new development for the TUMF Program, and 108 projects to date across the region have been completed using TUMF funds.
- Staff will be distributing jurisdiction-specific reports that identifies completed projects, funded projects, and regional projects.

#### **Update on the Economy and Financial Markets**

- Richard Babbe, Managing Director of Public Financial Management, provided an overview of the economic prospects of 2020, as well as potential future fiscal policy changes.
- While there has been a rebound in the economy, COVID-19 cases are increasing again and there may be some challenging times ahead in the near future.
- The Federal Reserve has a new inflation policy, which means rates may be lower for longer.
- WRCOG's TUMF investment portfolio continues to beat the 1 to 3-year U.S. Treasury Index returns.

#### The Impact of Automation on Employment

- Director Johannes Moenius, Institute of Spatial Economic Analysis, University of Redlands School of Business, presented research conducted by the Institute of Spatial Economic Analysis at the University of Redlands School of Business on the impact of automation on jobs in the subregion.
- The COVID-19 crisis has accelerated the shift to online retail with E-commerce sales experiencing a steep increase from around 12% in the first quarter of 2020 to 16.1% in the second guarter of 2020.
- 47% of U.S. employment could potentially be automated in the next decade or two, with the Inland Empire area being one of the most vulnerable regions in California, with 63% of jobs at risk due to automation in the next 20 years.
- The five largest occupation areas at high risk due to automation include the following:
  - Office and Administrative support
  - Transportation and Material Moving
  - Food Preparation and Serving Related
  - Sales and Related
  - Production
- To combat the risks of automation there should be a focus on the following:
  - Education: Higher education, certifications and apprenticeships and incentivizing businesses to invest in its workforce.
  - Enterprises: Data-driven industrial policy, repositioning commercial real estate spaces (retail, industrial, office) and supporting export opportunities.

- Entrepreneurship: Reduction of set-up and transaction costs for entrepreneurship while attracting the "creative class".
- Environment: Foster livable spaces, culture, entertainment, and institutions.

- WRCOG received its CAFR award for FY 2018/2019.

**The purpose of this item is to** provide information on Phase 2 of a COVID-19 fiscal impacts analysis produced by Economic Planning System which focuses on building economic resiliency for Western Riverside County.

#### **Requested Action:**

#### **Background**

Due to the COVID-19 pandemic, WRCOG commenced an assessment of the fiscal implications of the current public health crisis-driven economic downturn on Western Riverside County jurisdictions. The COVID-19 health crisis has required the curtailment of a broad range of activities and has already had a major economic impact on U.S. and global economies.

The curtailments on movement and gatherings and the associated closure of businesses has had an immediate and major impact on retail, hospitality, and leisure sectors and workers. Other industry sectors and connected businesses are also facing losses of business and downturns. While the duration of the health crisis and associated economic impacts were uncertain, a scenario-based approach was utilized to evaluate the potential level and timing of impacts on the tax revenues that typically accrue to Western Riverside County jurisdictions.

In the current COVID-19 climate, based on the near-term fiscal analysis, it was anticipated that WRCOG member jurisdictions would face an average of approximately 35% in General Revenues at immediate risk, with the area of Sales and Use Tax - Retail being the most heavily impacted. Similarly, 34% of jobs are in sectors at immediate risk. These immediate job sectors include Retail Trade (18%), Food Services and Drinking Places (10%), Accommodation (1%), Arts, Entertainment & Recreation (2%), and selected Services & Transportation (3%).

The assessment was conducted in two phases. Phase 1 is now complete and identifies the expected level and timing of impacts on the two tax revenues that will be most directly affected, including Sales and Use Tax revenues and Transient Occupancy Taxes. Phase 1 also identified the scale of job losses in the retail and hospitality sectors as well as the potential increases in the warehouse and distribution sectors.

Phase 2 built on the work from Phase 1 and involved additional analysis, looking in more detail at a targeted economic development approach to build economic resiliency for Western Riverside County. In the context of

numerous challenging economic trends, the following three opportunity areas can contribute to regional economic development, innovation, and resiliency goals:

- 1. Retail Real Estate: Opportunity to re-invent older shopping centers into vibrant mixed-use places with housing, office space, and retail.
- 2. Health Care Sector: Demographic tailwinds present opportunity for "middle class" and professional, scientific, and technical jobs in the health care sector.
- 3. Clean Energy Sector: Provides opportunity for a range of "middle class" installation / construction jobs as well as the possibility of attracting cleantech manufacturing.

Mr. Teifion Rice-Evans will be providing a presentation on the major highlights produced from Phase 2 of the economic analysis along with some actions local jurisdictions can take towards activating the opportunities presented.

**The purpose of this item is to** provide an update on the Riverside County Habitat Conservation Agency Activities.

#### **Requested Action:**

1. Receive and file.

The Riverside County Habitat Conservation Agency (RCHCA) is a Joint Powers Authority (JPA) formed for the purpose of acquisition, administration, operation, and maintenance of land and facilities for ecosystem conservation and habitat reserves for the Stephens' Kangaroo Rat (SKR), currently listed under the Endangered Species Act as endangered.

#### Background

In December 2015, the RCHCA Board of Directors and the WRCOG Executive Committee approved an agreement that transferred the duties of administration and management of RCHCA to WRCOG. In May 2018, full consolidation of RCHCA staff and operations was completed. RCHCA remains as a separate JPA with a separate budget. This effort creates cost saving measures, a succinct agency under one umbrella, streamlines processes, and reduces duplication of effort.

#### **Updates**

In 2020, the RCHCA accomplished several milestones in demonstrating species recovery, preserving biological diversity through adaptive land management and community involvement through educational outreach. The Agency received financial grants and service contributions from partners such as the Bureau of Land Management, California Conservation Corps, CAL FIRE, and the United States Department of Agriculture.

Stevens' Kangaroo Rat (SKR) Recovery Efforts: The endangered SKR is a species endemic to Western Riverside and Northern San Diego Counties. Recovery of an endangered species is considered when the critical levels that lead to that species' listing as endangered are fulfilled with sufficient population numbers and a low level of threats to maintain or increase populations in the future. In September 2020, the U.S. Fish and Wildlife Services (USFWS) published to the Federal Register a Proposed Rule to Reclassify SKR from Endangered to Threatened with a Section 4(d) Rule. The comment period closed on October 19, 2020, and USFWS is reviewing comments. This action serves as a demonstration of success in Western Riverside County for the many years of recovery efforts for SKR.

Next steps include a focus on the implementation of the Species Range-Wide Habitat Management and Monitoring Plan. Additionally, RCHCA continues species recovery efforts to support the 1997 Draft Recovery SKR Habitat Conservation Plan's finalization.

<u>Public Access Plan</u>: RCHCA cooperatively manages over 40,000 acres of land conserved for SKR. These lands reflect multiple ownerships, some of which are not currently open to the public, having different objectives as it relates to public access. Staff spends considerable hours and resources repairing lands from the impacts of unapproved access; therefore, a new approach is warranted to increase positive awareness and appreciation for these lands by allowing for managed public access. The Steele Peak Reserve Inaugural Trail conceptual design is complete. This design will establish a low-impact recreation opportunity for public access on conserved lands. The next phase is to complete the California Environmental Quality Act (CEQA) process.

<u>Innovative Research Projects</u>: The importance of innovative research is embraced by RCHCA. Development of useful practices based in science applicable to techniques used to support habitat and land management is imperative. RCHCA is working on projects such as using drone technology for aerial vegetation mapping, a Range-Wide Habitat Suitability Model, and the development of a Range-Wide Species Management and Monitoring Plan.

In the coming year, staff will focus on restoring several hundred acres of SKR habitat, the most ever conducted in one year, by broadcast seeding SKR-preferred plants. In addition to SKR habitat enhancement, staff will conduct monitoring in half of the SKR Reserve system to identify the status and trends of SKR populations and assist with adaptive management goals. In order to increase available habitat, staff will be adding over 1,000 acres into the prescribed burn vegetation management program jointly administered by RCHCA and CAL FIRE. This will require extensive biological and cultural surveys but once completed the program result in an extensive expansion of RCHCA management areas.

Finally, staff is working with the Riverside County Department of Waste Resources to develop conservation easements over RCHCA-owned riparian areas. After the County purchases the easements, it will receive approximately 29 acres of riparian mitigation credits available to offset impacts to riparian areas by landfill expansions and transportation infrastructure projects.
