8. REPORT FROM THE COMMITTEE CHAIR

Chair Dennstedt reported that WRCOG is still looking to collect challenge coins from Committee members' jurisdictions, which will be used for a shadow box that will be gifted to the key note speaker, Admiral William McRaven, at the June 12, 2025, General Assembly event.

9. REPORT FROM THE EXECUTIVE DIRECTOR

Dr. Kurt Wilson reported that it was the day of the release of the May Revise. Dr. Wilson emphasized focusing on the revenue side, which shows a downgraded forecast, due to uncertainties involving state / federal dynamics and potential recession risks.

California's budget is heavily reliant on personal income tax, particularly from the wealthiest residents. The May Revise is important because it follows the April 15 tax filing deadline, but this year's picture is unclear due to delays caused by disasters like fires, which deferred tax payments. The State is assuming \$3B in deferred personal income tax, but it's uncertain if that number is accurate. If the number is off, there could be budget issues later in the year, particularly around mid-to-late October

when collections are finalized. Lastly, Committee members were advised to to monitor the budget closely before the holidays.

11. GENERAL ANNOUNCEMENTS

Committee member Chuck Washington reported that the All-America City Award is presented annually to communities that effectively address local issues through civic engagement, collaboration, and innovation. Typically, winners include major cities and notable small towns. However, this year's list included an unusual finalist, WRCOG. Its inclusion is potentially historic, as it's rare for a COG to be recognized. The award acknowledges the collaborative efforts of the entire organization, with each member agency sharing in the achievement.

Committee member Chris Barajas of Jurupa Valley shared that the night rodeos will take place on June 6 - 7, 2025, in the City of Jurupa Valley. Different cultural events are being incorporated into the event prior to the rodeo.

Committee member Mike Lara reported that the City of Beaumont will be hosting the Cherry Festival May 29 - 31, 2025, and that there will be a parade that Saturday the May 31, 2025.

Summary:

WRCOG is preparing to launch the 10th round of its Public Service Fellowship Program, which connects college students and recent graduates with hands-on experience in the public sector. Since its inception in 2016, the Program has provided opportunities for 110 students to gain experience in fields such as planning, finance, IT, and administration. The Program helps develop a pipeline of talent for local government.

Purpose / WRCOG 2022-2027 Strategic Plan Goal:

The purpose of this item is to provide information on the 10th round of the Fellowship Program. This item aligns with WRCOG's 2022-2027 Strategic Plan Goal #6 (Develop and implement programs that support resilience for our region) and Goal #7 (Provide a safe, inclusive environment that values employees).

Discussion:

Background

The WRCOG Fellowship Program was created to cultivate the next generation of public service professionals by placing locally trained students in WRCOG member agencies. The Program provides meaningful, paid work experience and supports regional workforce development by encouraging students to stay and grow their careers in the subregion. Fellows have collectively contributed over 100,000 hours to western Riverside County through nine program cycles.

Approximately 85% of Fellow alumni are now employed across the region, while others have pursued graduate degrees or careers in related fields. WRCOG manages Program administration, while host agencies supervise and mentor Fellows during their placements.

Present Situation

WRCOG is preparing for its 10th round. The Program structure and logistics are as follows:

- Work Hours: Fellows work up to 960 hours per cycle, with a weekly cap of 30 hours.
- **Training:** WRCOG provides professional development and career readiness sessions throughout the Program.
- **Oversight:** WRCOG handles recruitment, onboarding, and administrative support; host agencies provide day-to-day supervision.

The cost structure for this round is based on two funding models: a 50/50 cost-share model and a full-cost model. An agency's eligibility for each model is determined by its participation in previous rounds of the Fellowship Program. The following outlines which WRCOG member agencies qualify for each funding model for the upcoming round.

50/50 Cost-Share Model (\$10,000 agency / \$10,000 WRCOG)

WRCOG invoices host agencies upon Fellow placement. If a Fellow exits early, WRCOG provides a prorated reimbursement for unused hours.

Round 9 Recap

Nine Fellows participated in the Fiscal Year 2024/2025 cycle and were placed with:

- · City of Lake Elsinore
- · City of Menifee
- County of Riverside District 5
- Eastern Municipal Water District
- Western Water (x2)
- WRCOG (x2)

Fellows engaged in professional development sessions and tours which focused on career development and public sector insights. Member agencies reported positive experiences, and many expressed interest in participating again. Staff will continue outreach to member agencies to refine and strengthen the upcoming round.
