#### 7. REPORT FROM THE COMMITTEE CHAIR

Chair Dennstedt reported that WRCOG experienced a significant fundraising loss for the General Assembly event following the departure of past Committee member Rita Rogers, who had previously generated approximately \$50,000 in sponsorships. To help close this gap, the Chair asked each Executive Committee member to recruit at least one new sponsor. Chair Dennstedt further noted that sponsorship expectations for cities, agencies, and districts may need to be revisited, and requested that table pricing and related sponsorship options be brought forward for future discussion. Chair Dennstedt also called for a detailed review of the Supporting Foundation's revenues and expenditures. Additionally, the Chair proposed re-establishing an ad hoc committee to support planning for General Assembly and encouraged members to consider participating. Chair Dennstedt concluded by reminding the Committee that a broader policy review will be needed and that the group should determine how best to approach that work.

#### 8. REPORT FROM THE DEPUTY EXECUTIVE DIRECTOR

Deputy Executive Director Chris Gray noted that anyone with questions about postcard sponsorships should speak with WRCOG's Bonnie Woodrome. Mr. Gray reported that the recent luncheon generated between \$40,000 and \$80,000 in sponsor commitments and thanked those Committee members who attended, and emphasized that sponsors participate in the General Assembly specifically to engage with Committee members. Lastly, Mr. Gray encouraged attendance at future events, noting that member presence helps attract and retain sponsors, and concluded by thanking the Committee and reminding everyone that the effort is ultimately about giving.

The Fiscal Year 2025/2026 budget anticipates \$365,500 in revenues against \$363,450 in expenditures; however, a budget amendment will be brought forward once certain expenditures have been finalized.

As of June 30, 2025, the Supporting Foundation has a fund balance of approximately \$126,000. The total fund balance serves as a useful measure of the Foundation's net resources available for spending at the end of the fiscal year.

#### Recommended Action(s):

1. Recommend that the Executive Committee approve an amendment to the WRCOG Bylaws clarifying that the Deputy Executive Director is authorized to act as the Executive Director when the Executive Director is unavailable.

#### **Summary**:

In the absence of the Executive Director, the authority of the Deputy Executive Director is somewhat vague. Approval of this item will clarify authority of the Deputy Executive Director during periods when the Executive Director is unavailable.

#### Purpose / WRCOG 2022-2027 Strategic Plan Goal:

The purpose of this item is to consider a Bylaws amendment to provide a clear and formal statement regarding the authority of the Deputy Executive Director to act during periods when the Executive Director is unavailable. This item supports WRCOG's 2022-2027 Strategic Plan Goal #4 (Communicate proactively about the role and activities of the Council of Governments).

#### Discussion:

#### **Background**

WRCOG's governing documents contain provisions that relate to delegated authority when the Executive Director is unavailable. Resolution Number 08-18 provides delegated signatory authority to the Deputy Executive Director for certain actions when the Executive Director is unavailable. Additionally, the Deputy Executive Director job description states that the position "serves as the Executive Director in their absence."

WRCOG's Bylaws provide the primary source that sets forth the powers and duties of the Executive Director. Legal counsel recommends that the Bylaws be amended to include an explicit statement addressing who is authorized to act when the Executive Director is unavailable. Such a provision would

provide a clear statement to third parties as to the role and authority of the Deputy Executive Director in
cases where the Executive Director is not available. The proposed amendment would align the Bylaws
with existing practice by clarifying that the Deputy Executive Director is authorized to act during such
periods.

# Resolution Number 01-26 amending WRCOG's Bylaws

#### **RESOLUTION NUMBER 01-26**

## A RESOLUTION OF THE EXECUTIVE COMMITTEE OF THE WESTERN RIVERSIDE COUNCIL OF GOVERNMENTS AMENDING ITS BYLAWS

**WHEREAS,** the Western Riverside Council of Governments ("WRCOG") is a joint powers authority consisting of the County of Riverside and 18 cities, the Eastern Municipal Water District, the Western Municipal Water District, and the Riverside County Superintendent of Schools, situated in Western Riverside County; and

**WHEREAS**, pursuant to Section 2.4.2 of the JPA, the WRCOG Executive Committee is authorized to exercise the powers of the JPA between sessions of the General Assembly; and

**WHEREAS**, Section 2.4.1 of the JPA grants the Executive Committee the authority to amend WRCOG's By-Laws ("Bylaws"); and

**WHEREAS**, the Executive Committee desires to amend the Bylaws to clarify who is authorized to act when the Executive Director is unavailable.

**NOW THEREFORE, BE IT RESOLVED** by the Executive Committee of the Western Riverside Council of Governments does hereby amend its Bylaws as follows:

<u>Section</u> 1: Article V, Section 1 of the Bylaws shall be amended to add a new subsection (D), to read as follows (new language is underlined):

"D. Acting Authority in the Absence of the Executive Director. In the absence or unavailability of the Executive Director, the Deputy Executive Director shall be authorized to act as the Executive Director and to exercise all duties and responsibilities assigned to the Executive Director under these Bylaws and WRCOG policies."

Section 2: The Resolution shall become effective upon adoption by the WRCOG Executive Committee.
