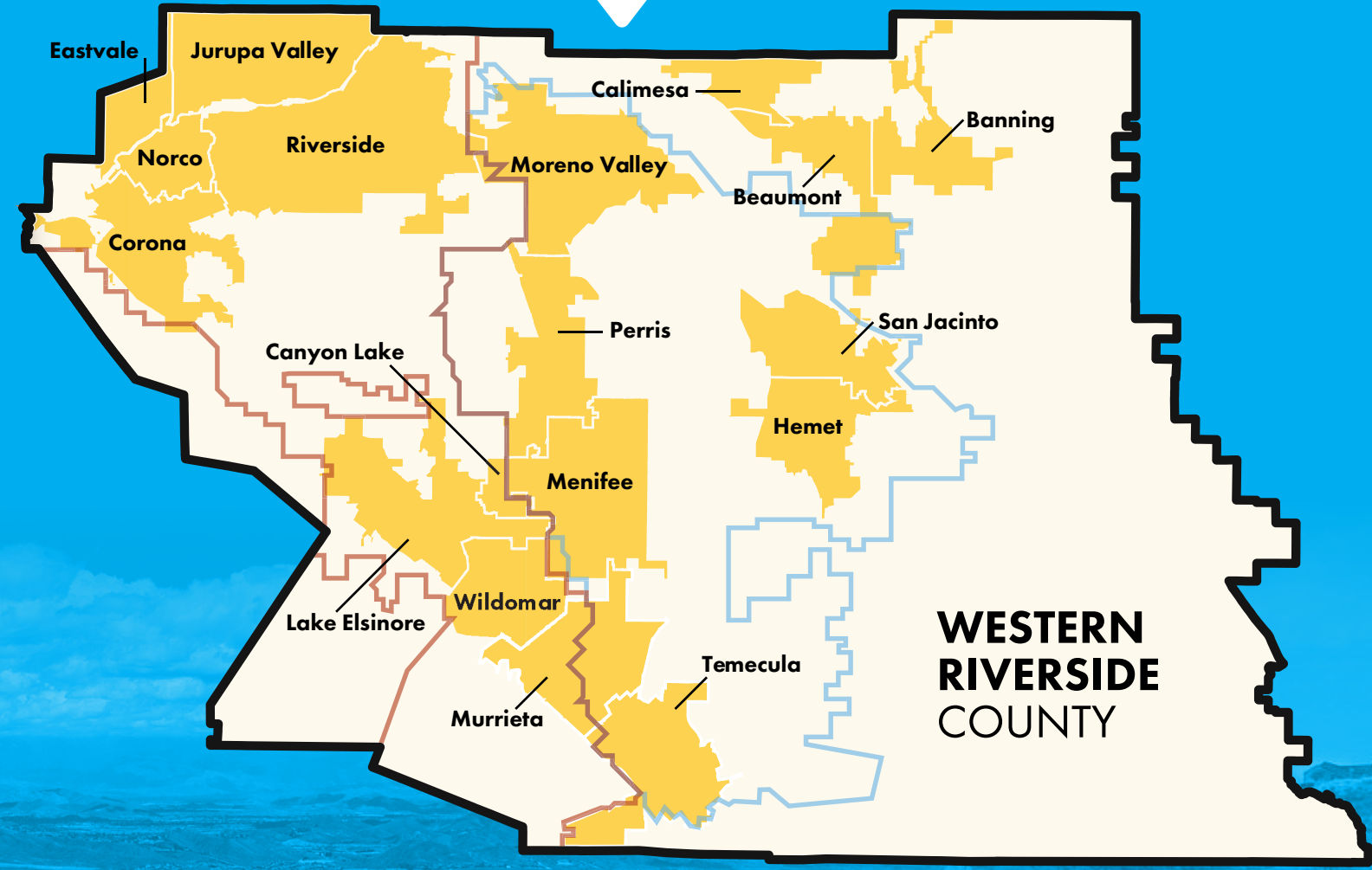

COMMITTEES



ADMINISTRATION & FINANCE (A&F)

The A&F Committee is a Standing Committee of the Executive Committee whose members are determined annually. Appointments are made by the Chair of the Executive Committee within certain roles reserved for the County Board of Supervisors, Water agencies, and Executive Committee Leadership. The Committee debates and evaluates complex or sensitive topics and provides recommendations to the Executive Committee. The Committee also has limited spending authority (\$200k).



TECHNICAL ADVISORY (TAC)

The TAC is comprised of the Chief Administrative/Executive Officer of each member agency (County Executive, City Manager, General Manager, Executive Director) and is tasked with providing the Executive Committee with counsel on issues of complex of technical nature. The Committee also convenes stakeholders, vendors, and providers for discussions of general concern or interest to the WRCOG sub-region, including legislative or regulatory issues.



FINANCE DIRECTORS (FDC)

The FDC is comprised of the Chief Financial Officers of member agencies. The Committee considers the fiscal implications of WRCOG programs and proposals. The FDC also convenes, evaluates, and facilitates discussions about issues affecting member agencies.



PLANNING DIRECTORS (PDC)

The PDC is comprised of the senior Planning officials from member agencies who convene to address issues of mutual concern, share strategies, and engage in planning-related topics affecting the WRCOG sub-region. The committee also serves as a forum for collaboration and resource sharing.



PUBLIC WORKS DIRECTORS (PWC)

The PWC is comprised of the senior Public Works officials from member agencies who convene to address issues of mutual concern, share strategies, and engage in infrastructure-related topics affecting the WRCOG sub-region. The committee also serves as a forum for information sharing and collaborative efforts.



SOLID WASTE

The Solid Waste Committee is comprised of members representing WRCOG member agencies who choose to participate in the program. The program provides technical assistance for a range of issues related to solid waste, recycling, and food recovery. The Committee shares best practices and resources related to regulatory and operational issues concerning solid waste.

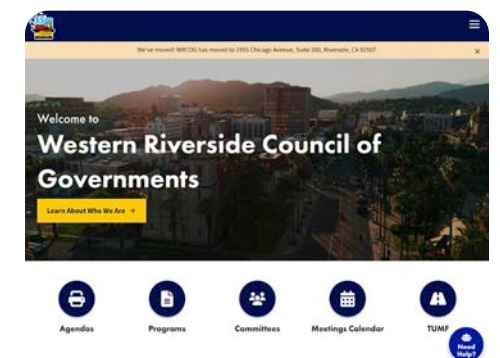

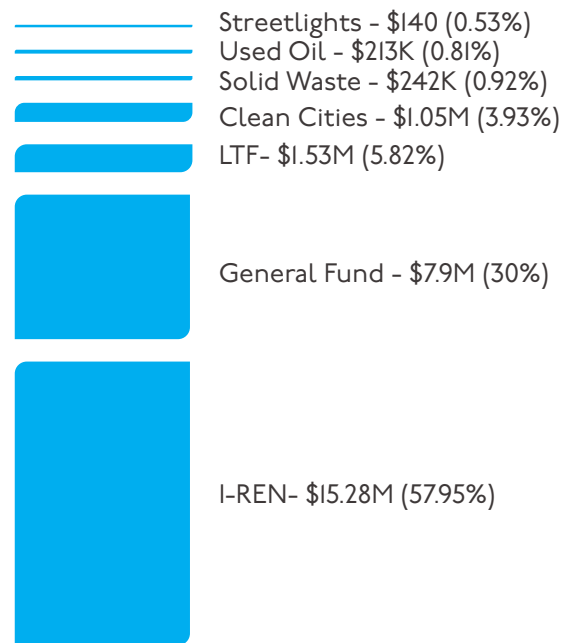

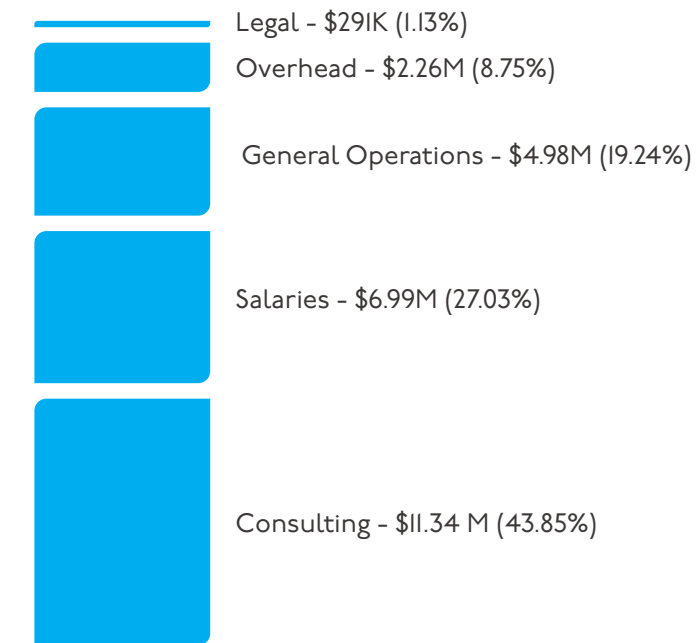


FISCAL YEAR 26/27 BUDGET

WRCOG'S STRATEGY

In addition to the Strategic Plan Goals, the Executive Committee directed a longer-term look at the Agency's finances to better identify and mitigate potential risks. This resulted in a fiscal modeling exercise that demonstrated the long-term fiscal health of each fund based on current activity, recessions, and other scenarios.

BUDGETING PRINCIPLES

- This year's budget was built on a set of guiding principles:
- Ensuring the fair distribution of funds and funding requests,
 - Requiring non-comprehensive programs (those which do not benefit the entirety of the member agencies) to be self-sustaining,
 - Focusing on the long-term health of each fund, and
 - Moving toward these goals in an incremental way when full scale immediate changes are impractical.

One of WRCOG's largest Programs and provides funding for transportation projects. Since its inception, over \$1 billion in TUMF projects has been funded.

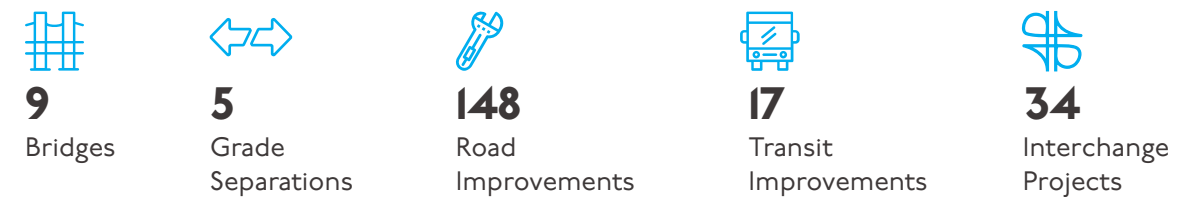

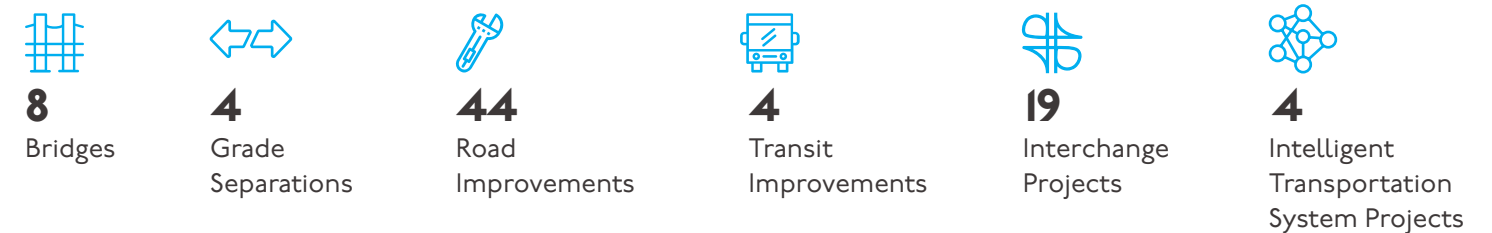
The Transportation Uniform Mitigation Fee (TUMF) program is a regional funding program that helps cities deliver transportation improvements across Western Riverside County. Through this coordinated approach, WRCOG member agencies improve mobility and for our communities across the region.

FISCAL YEAR HIGHLIGHT

FRENCH VALLEY PARKWAY PHASE II

The French Valley Parkway Phase II project in Temecula improved traffic operations and safety along northbound Interstate 15 (I-15) by addressing a long-standing congestion bottleneck between Winchester Road and the I-15/I-215 interchange. The project added approximately three miles of dedicated collector-distributor lanes, a new flyover bridge, and a separated roadway system that reduces merging conflicts and improves traffic flow for both commuters and freight. These improvements help streamline travel along this critical regional corridor and support continued growth in the surrounding communities.

TRANSPORTATION IMPROVEMENT PROJECT PROJECTION

Over the past year, TUMF revenue has seen an overall increase with strong growth occurring in the Cities of San Jacinto, Hemet and Eastvale.

This funding is providing capital to projects throughout the County such as I-15/SR 74, Esplanade Avenue Widening, 3rd St Grade Separation, 60/World Logistics Airport, I-10/Highland Springs Interchange, and many others.

The TUMF fees are collected and returned directly back into the program for project development.

PLANNING TECHNICAL ASSISTANCE

WRCOG provides planning technical assistance to member agencies through the Regional Early Action Planning (REAP) program, helping cities advance housing, land use, and community development priorities while supporting broader regional goals. REAP funding allows WRCOG to partner with cities on planning efforts that remove barriers to housing production, support sustainable growth, and strengthen local communities.

VEHICLE MILES TRAVELED MITIGATION EXCHANGE PROGRAM

WRCOG launched the Vehicle Miles Traveled (VMT) Mitigation Exchange Program in partnership with member agencies and regional stakeholders. The inaugural program provides a regional framework to address VMT impacts identified under the California Environmental Quality Act (CEQA) by allowing projects to offset impacts through the purchase of VMT credits generated by participating agencies' transportation and mobility projects. WRCOG serves as the Program Administrator and central coordinator for the Program.

GRANT WRITING

WRCOG continues to provide grant writing assistance to help member agencies secure funding for transportation, sustainability, and community improvement projects. By identifying funding opportunities, preparing applications, and coordinating regional support, WRCOG helps cities compete more effectively for state and federal funding.

LOVE YOUR NEIGHBORHOOD PROGRAM

The Love Your Neighborhood Program brings residents together to improve public spaces while promoting environmental stewardship across Western Riverside County. In partnership with Calimesa, Corona, Hemet, Murrieta, Riverside, Sun City, Temecula, and Wildomar, the program coordinates neighborhood cleanup events that encourage residents to take pride in their communities.

USED OIL RECYCLING PROGRAM

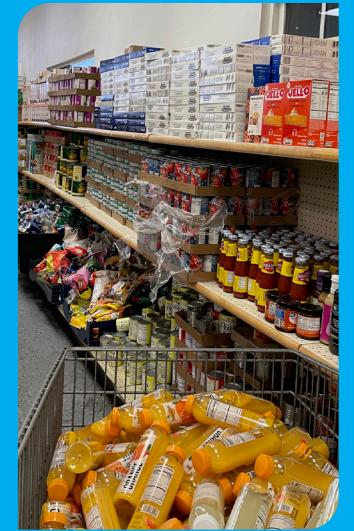


FOOD RESCUE PROGRAM

WRCOG's Food Rescue program supports regional efforts to reduce food waste while helping provide food to communities in need. Through partnerships with local jurisdictions and food recovery organizations, the program helps redirect surplus food that would otherwise go to waste to residents facing food insecurity. The program currently operates in partnership with the WRCOG member agencies of Jurupa Valley, Moreno Valley, Murrieta, Perris, and San Jacinto, helping expand food recovery efforts and improve access to nutritious food across Western Riverside County.

FELLOWSHIP PROGRAM

The WRCOG Fellowship Program helps develop the next generation of public service professionals by providing hands-on experience working alongside local governments and regional agencies. Fellows contribute meaningful work while gaining valuable professional experience that prepares them for careers in public service.

Since its inception, the program has facilitated eight cohorts training 117 fellows who have contributed more than 114,500 hours of service across Western Riverside County. Their work supports a wide range of regional initiatives, from economic development efforts to transportation and community projects.

ENERGY RESILIENCE PLAN

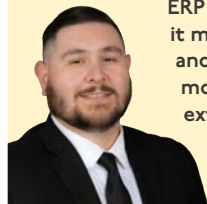

SOCALGAS REGIONAL ENERGY PATHWAYS AMBASSADOR PROGRAM

WRCOG continued its partnership with SoCalGas to support the Regional Energy Pathways Ambassador Program, helping connect public agencies and community institutions with energy efficiency resources and technical assistance. Through outreach, facility assessments, and project coordination, the program helps identify opportunities to reduce energy use and improve operational efficiency across the region.

The program engaged cities, school districts, special districts, and tribal partners throughout Western Riverside County, helping connect facilities with energy-saving upgrades and available incentive programs.

RESILIENT IE

Through the Resilient IE initiative, WRCOG supports regional planning efforts that help communities prepare for and respond to natural disasters and other emergencies. As part of this work, **WRCOG completed the Emergency Evacuation Network Resilience Study**, which evaluates how well the regional transportation system can support safe, reliable, and efficient evacuations during emergencies such as wildfires, earthquakes, and flooding.

The study provides a coordinated framework to help WRCOG member agencies strengthen evacuation planning, identify priority infrastructure improvements, and guide future funding strategies that enhance regional emergency preparedness and community resilience.



COMMERCIAL PROPERTY ASSESSED CLEAN ENERGY PROGRAM

WRCOG administers the Commercial Property Assessed Clean Energy (C-PACE) Program, which helps commercial property owners finance energy efficiency, renewable energy, water conservation, and seismic improvements through long-term property-based financing. By connecting property owners with financing and technical resources, the program helps accelerate building improvements that reduce energy use, lower operating costs, and support more sustainable development across Western Riverside County.

RIVERSIDE COUNTY HABITAT CONSERVATION AGENCY

WRCOG supports the work of the Riverside County Habitat Conservation Agency (RCHCA), which helps protect sensitive habitat and wildlife species across Western Riverside County while supporting responsible regional growth. Through habitat conservation planning, biological monitoring, and regional coordination, the program helps balance environmental stewardship with community development.

In 2025, RCHCA continued advancing conservation and research efforts across the region. Biologists completed the fourth year of monitoring efforts to better understand wildlife populations and habitat conditions within the reserve system. RCHCA also partnered with the San Diego Zoo Wildlife Alliance on research and conservation initiatives that support long-term species protection.

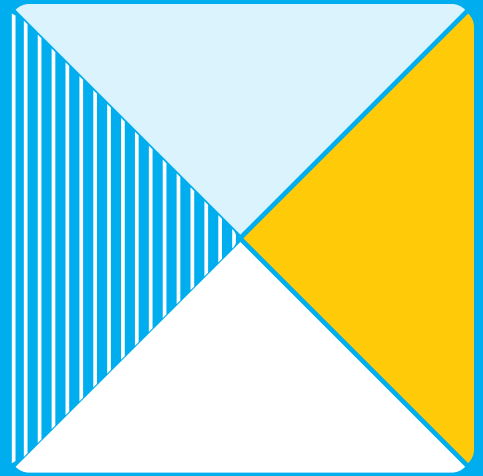
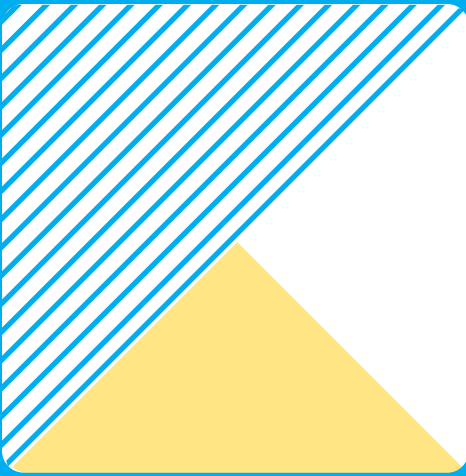
